Waiver and Release of Liability

I willingly assume full responsibility for the risks that I am exposing myself to and accept full responsibility for any injury or death that may result from participation in any activity or class while at, or under direction of, DG&F.

I acknowledge that I have no physical impairments, injuries, or illnesses that will endanger me or others.

This agreement shall be binding upon me, my successors, representatives, heirs, executors, assigns, or transferees. If I am signing on behalf of a minor child, I also give full permission for any person connected with DG&F to administer first aid deemed necessary, and in case of serious illness or injury, I give permission to call for medical and/or surgical care for the child and to transport the child to a medical facility deemed necessary for the well-being of the child.
